Wear goggles, half face-piece respirator with combined dust and vapour cartridge, full length clothing and PVC gloves. Adsorb spilled product and place in a sealable container for disposal. Wash down affected area with water plus detergent. Seek advice from local authority regarding disposal. Call the Fire Service: Dial 111. This product is combustible. Decomposition products in a fire are toxic and or irritant. Fire Wear PVC protective clothing and breathing apparatus. Extinguish fires with foam, dry chemical or carbon dioxide or fine-water spray. During a fire toxic fumes may be released. Cool sealed drums with water to prevent rupture due to thermal expansion. Contain run-off.
