IF THIS HAPPENS	DO THIS						
Tanker/Vehicle Accident	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. Call emergency services: Dial 111						
Spill or leak	Wear appropriate protective clothing. Exclude non-essential people from the area. Contain liquid spill and absorb with inert material such as soil, sand or absorbent granules and place in a sealable waste container. Dispose of waste safely in an approved landfill. Report large spills to Emergency Services at 0800 CHEMCALL (0800 243 622)						
Fire	Call the Fire Service: Dial 111. Fumes and combustion products produced in a fire may be toxic. Small Fire: Use dry chemical, CO ₂ , water fog or foam. Large fire: Use water fog, foam, or dry agent. If possible, use foam blanket to contain product. If safe to do so, move undamaged containers from fire area. Cool container with flooding quantities of water until well after fire is out.						
FIRST AID							
If Swallowed:	Never give anything by mouth to an unconscious person. If swallowed DO NOT induce vomiting. For advice, contact the National Poisons Centre on 0800 POISON (0800 764 766). Seek medical assistance immediately.						
If in Eyes:	Flush with plenty of water for 15 minutes holding eyelids open if necessary.						
If on Skin:	Remove contaminated clothing and wash the affected area thoroughly with soap and water. If a large area is affected seek medical assistance.						
If Inhaled:	Remove patient to fresh air. Lay down and keep warm and rested. If breathing is shallow or has stopped ensure airway is clear and apply resuscitation. Seek medical assistance immediately.

Storage: Store in tightly closed original container in a cool, dry well-ventilated area out of direct sunlight when not in use. This product can be stored in an unheated building. Do not store with food, feedstuffs, fertilisers and seeds. See product label for further handling / storage precautions relative to the end use of this product.
