#### EMERGENCY PROCEDURES

24 HOUR ADVICE IN AN EMERGENCY ONLY: 0800 243 622

IF THIS HAPPENS	DO THIS
TANKER/VEHICLE ACCIDENT	Switch off engine and electrical equipment. Keep people away. Warn other traffic. Check for spills and leaks. <b>Call the emergency services: Dial 111</b>
SPILL OR LEAK	Caution: Floors may be slippery if wet. Keep bystanders away. Wash splashes from skin and eyes immediately. Leave and/or avoid entering confined spaces. Wear overalls, chemical resistant boots and gloves (barrier multilayer, nitrile, neoprene), and safety glasses/goggles. Respiratory protection (with organic vapour cartridge) required for any spill other than minor. Prevent further spillage or leakage. Absorb spillage with inert material such as spill kit, sand or cat litter. Collect and place in a sealable container for disposal. Wash down affected area with water and detergent. Absorb and collect washings for disposal. Dispose of safely to a suitable landfill.
FIRE	<b>Call the Fire Service: Dial 111.</b> Wear protective clothing including self-contained breathing apparatus. Toxic fumes may be released. Keep people away. Extinguish fires with foam, dry chemical, carbon dioxide or fine water spray. Cool other containers to prevent rupture. Contain run-off.

#### FIRST AID

IF SWALLOWED	Do NOT induce vomiting. <b>For advice call the National Poisons Centre 0800 764 766 or a Doctor immediately</b>
IF IN EYES	Hold eyes open and rinse with water for several minutes. Remove contact lenses if easy to do so. Call the National Poisons Centre 0800 764 766 or a Doctor if irritation persists.
IF ON SKIN	Immediately wash affected area with soap and water. Wash contaminated clothing before reuse. Call the National Poisons Centre 0800 764 766 or a Doctor if irritation persists.
IF INHALED	Immediately move to fresh air and rest. Maintain half upright position if breathing is difficult. <b>For advice call the National Poisons Centre 0800 764 766 or a Doctor immediately.</b>
