#### 4. FIRST AID MEASURES

# Advice for firefighters

#### 10. STABILITY AND REACTIVITY

Very low toxicity if swallowed. Harmful effects not anticipated from swallowing small amounts.

# **Teratogenicity**

For similar active ingredient(s): Clopyralid caused birth defects in test animals, but only at greatly exaggerated doses that were severely toxic to the mothers. No birth defects were observed in animals given clopyralid at doses several times greater than those expected during normal exposure.

# Reproductive toxicity

For the active ingredient(s). Aminopyralid. In animal studies, did not interfere with reproduction.

# Mutagenicity

For the active ingredient(s): In vitro genetic toxicity studies were predominantly negative. Animal genetic toxicity studies were negative.
