

**NITROPHOSKA FERTILISER****BATCH NUMBER:****BAGGING DATE:**

Read label carefully and obtain special instructions before use. Do not handle until all safety precautions have been read and understood.

**PRODUCT DESCRIPTION**

Nitrophoska Extra is a compound fertiliser containing all nutrients in one granule. It is used for speciality crops and all crops under glass and home garden. Can also be used on lawns. Contains potassium sulphate so it can be used on chloride-sensitive crops such as flowers, potatoes, lettuce, tomatoes, strawberries, citrus and avocados.

**DIRECTIONS FOR USE**

Rate of use: 20-30 grams/square metre for each successive crop. For lawns, flowers, citrus and avocados apply every 6 weeks or as required. Water into soil after application. Avoid fertiliser contacting paths, hard surfaces and driveways as the fertiliser may stain or discolour these surfaces.

**COMPONENTS**

Nitrogen (N): 12%. Phosphorus (P): 5.2%. Potassium (K): 14%. Sulphur (S): 8%. Magnesium (Mg): 1.2%. Calcium (Ca): 3.8%.

**CONTAINS**

Ammonium Nitrate: 10-25%

**HANDLING PRECUATIONS AND STORAGE****HANDLING**

Read label before use. Wash hands thoroughly after handling. Wear protective clothing. Do not eat, drink or smoke when using this product. Avoid dust formation. Ensure good ventilation of the work station. Wear personal protective equipment. Avoid contact with skin and eyes. Keep away from any flames or sparking source. **STORAGE**

Keep out of reach of children. Store in a well-ventilated place. Keep cool. Keep away from food, drink and animal feeding stuffs. Do not store with: Organic materials. Protect from moisture. Store away from heat.

**ECOLOGICAL INFORMATION**

HSNO Class: hazardous to the aquatic environment chronic Category 4 *Note: hazardous to the aquatic environment acute Category 2 and acute Category 3 have not been adopted.*

**IF IN EYES**

Flush with plenty of water for several minutes, holding eyelids open if necessary. Remove contact lenses if present and easy to do. Continue rinsing for at least 15 minutes. If eye irritation persists seek medical assistance.

**IF ON SKIN**

Wash skin with plenty of water. If skin irritation occurs: Get medical advice/ attention.

**IF INGESTED**

Never give anything by mouth to an unconscious person. Rinse mouth. Call a POISON CENTER or doctor/physician if you feel unwell.

**IF INHALED**

Remove patient to fresh air. Keep at rest in comfortable position for breathing. If breathing is shallow or has stopped ensure airway is clear and apply resuscitation. Seek medical assistance if needed.
